

2015 Kids Safe Saturday/Paris Art Fair

Food Concessions Regulations/Stipulations – Deadline to Apply COB 5/1/15

- Think Child Safety has the right to refuse to allow vendors to exhibit offensive or degrading materials. The use or sale of alcohol, tobacco, drugs, weapons, profanity, inappropriate dress, and unprofessional conduct will not be tolerated.
- Food Vendor booths are first come first served, some will be inside the pavilion on the north side of the civic center, and some will be along the north sidewalk against the civic center. Vendor placement is at the sole discretion of the TCS steering committee, and will be based on size of area required, and power/water needs. Water and Power are included in the registration fees WHEN AVAILABLE. You are responsible for your own extension cords and water hoses. Concession spots are UP TO 20' wide x 10 deep'. (Exceptions may be made in certain circumstances)
- Food trucks, trailers and carts are all encouraged to attend. There will be no food concession vendors allowed inside the civic center.
- Vendors are responsible for booth set-up and display. Please load and unload as quickly as possible keeping in mind the other vendors. Fire exits and lanes must not be blocked at any time. Think Child Safety volunteers will be available to assist vendor's needs during set up and break down.
- Vendors with prepared food products will be considered food concessionaires and are limited to outside concession stands.
- Concessionaires of similar products will be limited thus providing vendors less competition the day of the event, subject to the sole discretion of the TCS steering committee.
- A health permit will be required. All vendors must comply with the Health Department regulations including the need to be covered. There will be a site inspection from the Health Department the day of the event.
- All displays and merchandise MUST remain within the dimensions of the booth space leased. Contact the Think Child Safety at thinkchildsafety@paristexas.gov for questions concerning logistics. All vendors are responsible for the physical safety of their customers. Be mindful of ropes and electrical cords. (This is a safety event!)
- Concession stands must remain intact and open until the close of the event. Booths must be broken down by 5pm on the day of the event. Vendors closing before 3pm or vendors who remain at the Love Civic Center after 6pm will be subject to a \$50.00 clean up fee.
- The vendor is solely responsible for his/her merchandise, property and business transactions. Vendors are required to have a Texas sales tax permit and must provide a copy with this application, no exceptions.
- Think Child Safety does not provide security and is not liable for damage or loss of personal property. Merchandise left unattended is done so entirely at the owner's risk. However additional patrol by Paris PD will be used Friday night into Sat morning.
- Think Child Safety reserves the right to refuse admission to any vendor(s) or refuse to rent/renew rental of lot(s) at its sole discretion, and reserves the right to amend or change the policies and procedures without prior written notice.
- Vendors may not assign, loan or sublease booth space to another person or entity without specific prior authorization from Think Child Safety.
- Cancellations must be received in writing before the cancellation deadline of May 1 and will incur a \$50.00 cancellation fee. Rain or shine, Kids Safe Saturday at the Paris Art Fair will go on. No cancellations or transfers allowed after cancellation deadline of May 1st.
- Vendors must be prepared to bring 50-100' of power cable extensions due to distance to electricity.
