



# 2019 Kids Safe Saturday



## KSS Booth Regulations and Stipulations

- The event is **Saturday, May 4, 2019, 10a-2p** at the **Love Civic Center**, 2025 S Collegiate, Paris, TX. Setup is Friday, May 3 from 3p-6p, and Saturday May 4, 7a-9a. Tear down is 3p-5p.
- Kids Safe Saturday booths/vendors must provide a service/product to the participants at no charge. There will be no retail selling of any product/service within the Kids Safe Saturday Event.
- There is no charge for a Kids Safe Saturday booth, and you may not charge for your product or service.
- Think Child Safety has the right to refuse to allow vendors to exhibit offensive or degrading materials. The use or sale of alcohol, tobacco, drugs, weapons, profanity, inappropriate dress, and unprofessional conduct will not be tolerated.
- Rain or shine, Kids Safe Saturday will go on. Application deadline is April 20th, 2019.
- Kids Safe Saturday booths are pre-assigned, and will have one 3x8 table to use. Additional tables are available by request based on availability.
- All KSS Booths will be inside in the Civic Center. 110v power is available on a limited basis. Vendor spots are 10' wide x 10' deep'. (Exceptions may be made in certain circumstances, we are flexible!) Larger apparatus and displays will be outside the Civic Center.
- Vendors are responsible for booth set-up and display. Please load and unload as quickly as possible keeping in mind the other vendors. Fire exits and lanes must not be blocked at any time. Think Child Safety volunteers will be available to assist vendor's needs during set up and break down.
- All displays and merchandise **MUST** remain within the dimensions of the booth space allotted. Contact the Think Child Safety at [thinkchildsafety@paristexas.gov](mailto:thinkchildsafety@paristexas.gov) for questions concerning logistics. All vendors are responsible for the physical safety of their customers. Be mindful of ropes and cords. (This is a safety event!)
- Vendor stands must remain intact and open until the close of the event. Booths must be broken down by 5pm on the day of the event.
- Vendors must remove all trash, boxes, and merchandise before check out time of 5pm. All exhibits will be inspected by event staff prior to deposit being returned.
- Think Child Safety provides security Friday night into Sat morning, however we are not liable for damage or loss of personal property. Merchandise left unattended is done so entirely at the owner's risk.
- Think Child Safety reserves the right to refuse admission to any vendor(s) or refuse to rent/renew rental of lot(s) at its sole discretion, and reserves the right to amend or change the policies and procedures without prior written notice.
