Release of Liability and Indemnity for Minor Participants

Please Read Before Signing

In consideration of _____, my child/ward ("Child"), being allowed to participate in any way in the City of Paris Summer Camp programs ("Camps") and related events and activities, the undersigned, on behalf of myself, Child, my spouse, and on behalf of my/our heirs, assigns, personal representatives and next of kin, **does hereby release and agree to indemnify and hold harmless the City of Paris its officers, employees, and agents, including any volunteers ("City") from any and all claims for personal injury, death, property damage, or any type of claim or damage (including but not limited to attorney's fees or litigation expenses) resulting from Child's activities, whether arising from the negligence of City or otherwise, in connection with participation in the Camps or the participation of any family member or guest of the undersigned, to the fullest extent of the law. I, for myself, my spouse, Child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, hereby indemnify and hold harmless City from any and all liabilities incident to Child's involvement or participation in Camps, whether or not arising from the negligence of myself or Child, to the fullest extent of the law.**

I have explained to Child the risks associated with the Camps' activities, his or her responsibilities for adhering to the rules and regulations thereof, and I certify by my signature below that my child understands those risks and responsibilities.

I assume all risks and hazards incidental to such participation in Camps and activities related thereto and consent for Child to receive first aid and/or emergency care by a qualified Emergency Medical Technician or physician or other person qualified to render medical assistance in the event Child suffers an injury during sanctioned games and activities.

I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in Child's readiness for participation and/or in the program itself, I will remove Child from the participation and bring such attention of the nearest official or volunteer immediately.

I, for myself, my spouse, and Child, have read this release of liability and assumption of risk agreement, fully understand its terms, understand that we have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.

I understand that there will be media and promotional coverage of Camp games and activities and I give my consent to publish Child's name and picture for such purposes. I hereby grant City the irrevocable, unrestricted right to use, publish, display and distribute materials bearing Child's name, voice, likeness or any other identifiable representation of myself and my family members. These materials may appear in any form, style, color or medium whatsoever (including, without limitation, photographs, video tapes, films, sound recordings, software, drawings, prints, broadcast, internet and electronic media). I agree that all material containing identifiable representation of Child (including without limitation, all negatives, plates and masters of any photographs, files, prints or tapes) shall be and remain the sole and exclusive property of City. I hereby release and forever discharge City from any and all liability and damages relating to Child's name, voice, likeness or any identifiable representation of Child. I hereby waive any right I may have to inspect or approve the finished materials or any part or element thereof that incorporates Child's name, voice, likeness or any other identifiable representation of Child, myself and my family. I have agreed to the above in consideration of the opportunity given to my child by City to appear in these materials.
